# LOUDOUN GROWN EXPO Rules, Regulations and Information

#### Load-In & Load-Out

Load-in will be Friday, February 28,2020 7 pm-9pm. Hand trucks may be used to carry your supplies. All exhibits must be completely removed by 6pm, Saturday, February 29,2020.

#### **Electrical Requirements**

If you require electricity, please indicate the equipment/appliances and electrical load requirements you would like to use in order for the Town to evaluate your needs. The Exhibitor or vender must supply appropriate power strips and extension cords.

#### **Non-Discrimination Policy**

The Town of Purcellville provides equal opportunity to all existing and prospective exhibitors without regard to race, color, sex, gender identity, sexual orientation, political affiliation, religion, age, marital status, disability or handicap, veteran status or national origin or other criteria protected bylaw.

#### **Exhibitor and Vendor Responsibilities**

- a) Adherence to all local, state and federal laws, whether stated or unstated in this application including tax payments.
- b) Responsible for the conduct and demeanor of their employees, agents and/or volunteers at the event.
- c) Must keep booths open during the entire event (12pm-5pm). Failure to do so may result in exclusion from future events.
- d) Any activity must take place within the booth space. This would include sales, giveaways, contests, etc.
- e) No amplification devices can be used.
- f) Signage may not extend outside of booth.

# Exhibitors Serving Tastings of Alcoholic Beverages

- a) All exhibitors serving alcoholic beverages must include their Retail ABC License when they submit their application.
- b) Alcoholic beverages must be in containers that comply with all Virginia ABC laws and regulations.
- c) Alcoholic beverage tastings and sales of unopened bottles of alcoholic beverages must occur within the respective exhibitor's booth space.
- d) Exhibitors offering samples of wine or cider beverages are responsible for regulating the amount of samples that are consumed at their space, for collecting the separate fees for those samples and for unopened bottles of alcoholic beverages to go.

e) Each exhibitor with alcoholic beveragesamples will need to submit their remote Virginia ABC license **no later than February 13,2020.** 

#### **Exhibitor and Vendor Insurance**

"All Exhibitors are required to maintain general liability insurance. Exhibitors who are serving and/or selling food, alcohol or any other product at the Loudoun Grown Expo must maintain a general liability policy with a minimum coverage of \$1,000,000 combined single limits. Coverage is to be on an occurrence basis with an insurer licensed to conduct business in the Commonwealth of Virginia. The insurer must have an A. M. Best rating of A- or better. The insurer must add the Town of Purcellville and Bush tabernacle as additional insured by endorsement to the general liability policy. A Certificate of Insurance (COI) and the additional insured endorsement shall be provided to the Bush Tabernacle by the exhibitor prior to the event evidencing compliance with these insurance requirements. If you need information about how to obtain this insurance, please contact the Bush Tabernacle.

#### **Cancellations & Exclusions**

Bush Tabernacle will fully refund the registration fee if cancellation notification is received, in writing, on or before **January 31st, 2020.** 

You are permitted to distribute and/or sell products in compliance with all Virginia laws. All items to be sold must be listed on the exhibitor application and be reviewed by the Bush Tabernacle.
